1. Candidates must be Himachali Bonafide.
2. AYUSH Vibhag will adopt a centralized counselling system for the allotment of seats.
3. AYUSH Vibhag will maintain two separate merit lists i.e. for all male applicants and for all female applicants.
4. For the first three rounds of the counselling AYUSH Vibhag will allot the seats as per the reservation roster and on fourth round onwards all the vacant seats will be treated as Unreserved & accordingly, will be allotted.
5. Minimum educational qualification for the Panchkarma Technician Course is **12<sup>th</sup>** and admission will be purely on merit (12<sup>th</sup> class marks) cum option basis. In case of equal percentage of the candidates the upper age will be considered first. Allocation of Institutions/ Hospitals to the selected candidates will be done on merit cum option basis and the selected candidates will have to report in the concerned Hospital for physical verification of documents.
6. Application must be accompanied with self-attested copies of Educational Qualifications, class 10<sup>th</sup> certificate, Himachali Bonafide Certificate, Certificate of caste/ category (if any) shall be submitted on or before the last date of application. In case of any dispute, the decision of the Director AYUSH, H.P shall be final. The Department shall not be liable to give any appointment on the basis of the said course.
7. Candidate should be Physically & Mentally fit.
