5. The quoted rates shall remain valid for a period of one year from the date of opening of the quotation. The validity period should be clearly mentioned in the quotation.
 6. No advance payment shall be made in any case. Payment shall be released only after satisfactory receipt, installation (where applicable) and acceptance of the items by the Institute.
 7. In case any material is found to be defective, damaged or not conforming to the required specifications, the supplier shall be responsible for its replacement at his own cost, including transportation and other incidental charges.
 8. No separate insurance charges shall be admissible unless specifically approved by the Institute. The supplier shall be responsible for insuring the consignment against transit risks, at his own cost, if considered necessary.
